Qualifications and Obligations:

1. Duke must be 25 years of age or older.
2. The fee for Duke is \$400.00. Payment may be made in full at the time of submission of this application. Or a \$200.00 initial deposit is required with this application and two additional installment payments of \$100.00 by July 1st and \$100.00 by August 1st. **All dues must be paid, in full, two weeks prior to coronation.**
2. If application is not approved, all monies submitted with this application will be refunded.
4. **Substitutions are not allowed.**
5. All paraphernalia used in the Krewe's activities, (costumes, floats, etc), are the property of Selene, Inc.
6. Duke is required to participate in the coronation. If he does not, he forfeits his position without a refund.
7. Duke must provide standard Black Tuxedo for Coronation and Parade Ride. If drawn as King, must provide an all white tuxedo for the Parade Ride.
8. If chosen King, applicant understands that he shall be allowed one attendant and that no DJ will be allowed on Royalty float.

Rider does further indemnify Krewe against any and all claims by the individuals hereinafter named and undersigned, their heirs, agents and/or assigns, including but not limited to, any and all rights, claims, causes of action, demands, damages, allegations or suits of any kind or nature whatsoever, and particularly any and all claims for general and/or special damages as a result of any personal injury sustained by them during or as a result of the activities of those individuals hereinafter named and undersigned in connection with the Krewe of Selene.

This hold harmless agreement shall be binding upon the parties hereto, their agents, successors and/or assigns.

The undersigned hereby declares that this hold harmless agreement has been completely read and is fully understood and voluntarily accepted for the express purpose of precluding forever any claims against Krewe arising out of the aforesaid activities.
