LADY IN WAITING MEMBERSHIP APPLICATION 2018-2019

- 1. All members, returning and new, must submit a new, fully completed, membership application by August 1, 2018. The annual dues for Ladies In Waiting are \$300.00 to be paid in full no later than August 1, 2018. Multiple family applicants will receive a discount Payments are accepted only at general membership meetings or as delivered to the Krewe's post office box address. Applications will only be accepted with full payment. Each rider/family is permitted one male chaperone, who must be at least 25 years old.
- 2. Every Lady in Waiting must wear white floor length debutant dresses with long white gloves and their chaperone must wear a black tuxedo. **PHOTO PICTURE OF DRESS MUST BE APPROVED BY AN OFFICER.** No Exceptions.
- 3. THE ANNUAL DUES ARE NOT TRANSFERABLE OR REFUNDABLE. SUBSTITUTIONS IN MEMBERSHIP FOR PARTICIPATION IN ANY KREWE ACTIVITY ARE NOT ALLOWED. NO EXCEPTIONS.
- 4. Applications for membership will not be processed without receipt of the fully executed application. That is, both the completed application, full dues and the Indemnification and Hold Harmless Agreement. If application is not approved, the payment will be refunded.
- 5. Applicant understands that the Krewe having a Ladies In Waiting float is contingent on receiving a minimum of 6 applications. Should the Krewe not meet this goal, the float may be cancelled and all dues relating to the Ladies in Waiting will be refunded, accordingly.
- 6. All applicants must be between the ages of 11 and 15, at the time of the parade (March 1, 2019). A copy of your birth certificate must be attached to this application.
- 7. Applicant understands that each Ladies in Waiting membership is inclusive of only her parade day ride. No other Krewe functions are included in her membership.
- 8. **The Selene Logo** is trademarked. Duplication of the logo is only allowed with written approval by the board of directors. No vendor shall be permitted to sell their merchandise, at any Selene function, without written consent by the board of directors.
- 9. There is to be no advertising or any marketing objects thrown from the floats. This includes business or political advertising.
- 10. A service charge of \$25.00 will be assessed on all NSF checks.
- 11. When submitting any payments to the Krewe of Selene, check or money order must indicate for whom and what the payment is intended. If payment is for more than one item and/or one member, please indicate the breakdown of how to apply the payment on the check. You should always receive a cash receipt for all cash payments. It is the responsibility of the member to prove payment has been made should any discrepancy arise.
- 12. Member agrees to adhere to all rules and regulations as established by the board of directors and officers regarding attendance and conduct for the parade. These rules will be available to each member prior to the parade. Should the City and/or Parish Government pass any ordinances pertinent to the Krewe and/or its parade, Selene will enforce, the ordinance, accordingly.
- 13. Assessments will be made against members for failure to comply with Krewe rules. Should a member violate any of the Krewe's rules and regulations, the board of directors reserves the right to terminate their membership. At such time of termination, the member will forfeit any monies.
- 14. Members agree there are no refunds given on any membership dues, court fees, or any other purchases related to the Krewe of Selene. This includes any situations involving Acts of Nature, decisions by the Officers of the Krewe of Selene, the City of Slidell, and/or the Slidell Police Department.
- 15. By submitting this executed Lady In Waiting Membership Application, member agrees that they are participating in all Krewe activities at their own risk and hereby further agree to hold harmless the Krewe for any injury, etc. that may occur in association with any Krewe of Selene's activities.

This hold harmless agreement shall be binding upon the parties hereto, their agents, successors and/or assigns.
The undersigned hereby declare that this hold harmless agreement has been completely read and is fully understood and voluntarily accepted for the express purpose of precluding forever any claims against Krewe arising out of the aforesaid activities.
