MEMBERSHIP APPLICATION 2018-2019

1. All members, returning and new, must submit a new, fully completed, membership application. The annual dues are **\$480.00 to be paid in full no later than July 9th, 2018**. Payments are accepted only at general membership meetings or as delivered to the Krewe's post office box address. Should payments be made in installments rather than full payment with application, the payment deadlines are as follows: **\$160.00 by May 1st; \$160.00 by June 1st; and \$160.00 by July 9th.**
2. Should your annual dues not be paid, in full, by July 9th, 2018, a late fee of \$50.00 will be automatically assessed to your account. Should your annual dues not be paid, in full, by August 1st 2018, you will automatically be considered as resigning from the organization. **NO EXCEPTIONS.** Final payment may be postmarked by July 9th, 2018.
3. **THE ANNUAL DUES ARE NOT TRANSFERABLE OR REFUNDABLE. SUBSTITUTIONS IN MEMBERSHIP FOR PARTICIPATION IN ANY KREWE ACTIVITY ARE NOT ALLOWED. NO EXCEPTIONS.**
4. **Applications for membership will not be processed without receipt of the fully executed application, the fully executed Indemnification and Hold Harmless Agreement and at least the minimum \$160 first installment.** If application is not approved, the payment will be refunded. If accepted, the initial installment payment will be credited to your annual dues.
5. All applicants must be at least 21 years of age.
6. **The Selene Logo** is trademarked. Duplication of the logo is only allowed with written approval by the board of directors. No vendor shall be permitted to sell their merchandise, at any Selene function, without written consent by the board of directors.
7. There is to be no advertising on any objects thrown from the floats. This includes business or political advertising.
8. Should a member resign from the Krewe, a letter of resignation must be sent to the Krewe's post office box addressed by August 1st, 2018. Otherwise member remains responsible for the full balance of dues payments. **Any payments made to the Krewe prior to resignation are non-refundable. NO EXCEPTIONS.**
9. A service charge of \$25.00 will be assessed on all NSF checks.
10. When submitting any payments to the Krewe of Selene, check or money order must indicate for whom and what the payment is intended. If payment is for more than one item and/or one member, please indicate the breakdown of how to apply the payment on the check. You should always receive a cash receipt for all cash payments. It is the responsibility of the member to prove payment has been made should any discrepancy arise.
11. **Member agrees to adhere to all rules and regulations as established by the board of directors and officers regarding attendance and conduct for any function sponsored by the Krewe of Selene, including but not limited to, all socials, fundraisers, float gatherings, the Friday night party, the coronation ball or the parade. These rules will be available to each member at the general membership meetings and on the Krewe's website prior to each of these events. Should the City and/or Parish Government pass any ordinances pertinent to the Krewe and/or its parade, Selene will enforce, the ordinance, accordingly.**
12. Assessments will be made against members for failure to comply with Krewe rules. Should a member violate any of the Krewe's rules and regulations, the board of directors reserves the right to terminate their membership. At such time of termination, the member will forfeit any monies.
13. Members agree there are no refunds given on any membership dues, court fees, or any other purchases related to the Krewe of Selene. This includes any situations involving Acts of Nature, decisions by the Officers of the Krewe of Selene, the City of Slidell, and/or the Slidell Police Department.
14. By submitting this executed Membership Application, member agrees that they are participating in all Krewe activities at their own risk and hereby further agree to hold harmless the Krewe for any injury, etc. that may occur in association with the Krewe of Selene's activities.

This hold harmless agreement shall be binding upon the parties hereto, their agents, successors and/or assigns.

The undersigned hereby declares that this hold harmless agreement has been completely read and is fully understood and voluntarily accepted for the express purpose of precluding forever any claims against Krewe arising out of the aforesaid activities.
