APPLICATION FOR LADY IN WAITING 2021-2022

1. The fees for Ladies-In-Waiting are **\$300.00 which can be paid in installments of \$100.00 by July 1, August 1, and September 1, 2021.** All applicants must be between the ages of 11 and 15, at the time of the parade (February 25, 2022). A copy of your birth certificate must be attached to this application.
2. Multiple family applicants will receive a discount. Payments are accepted only at general membership meetings or as delivered to the Krewe's post office box address. Applications will be accepted with one installment payment. Each rider/family is permitted one male chaperone, who must be at least 25 years old.
3. Every Lady-In-Waiting must wear white floor length debutant dresses with long white gloves to the elbow. Their chaperone must wear a black suit and tie). **PHOTO PICTURE OF DRESS MUST BE APPROVED BY AN OFFICER.** No Exceptions.
4. **Applicant understands that the Krewe having a Ladies-In-Waiting float is contingent on receiving a minimum of 6 applications. Should the Krewe not meet this goal, the float may be cancelled and all dues relating to the Ladies-in-Waiting will be refunded, accordingly.**
5. **Applications will not be processed without receipt of the fully executed application. That is, both the completed application, full dues and the Indemnification and Hold Harmless Agreement.** If application is not approved, the payment will be refunded.
6. Applicant understands that fee for Ladies-in-Waiting is inclusive of only her parade day ride. No other Krewe functions are included in her membership.
7. Krewe of Selene will host a lunch/dinner for the ladies prior to the Parade for all Ladies in Waiting

Rider hereby releases and holds harmless Krewe from and forever discharges them, their heirs, agents and assigns from any and all rights, claims, causes of action, demands, damages, allegations or suits of any kind or nature whatsoever, and particularly any and all claims for general and/or special damages as a result of any personal injury sustained by them during or as a result of the activities of Rider and those individuals hereinafter named and undersigned in connection with the Krewe of Selene parade or any function sponsored by the Krewe of Selene, including but not limited to ALL socials, fundraisers, float gatherings, the Friday night party, the coronation ball or other functions related in any way to the Krewe of Selene.

Rider does further indemnify Krewe against any and all claims by the individuals hereinafter named and undersigned, their heirs, agents and/or assigns, including but not limited to, any and all rights, claims, causes of action, demands, damages, allegations or suits of any kind or nature whatsoever, and particularly any and all claims for general and/or special damages as a result of any personal injury sustained by them during or as a result of the activities of those individuals hereinafter named and undersigned in connection with the Krewe of Selene.

This hold harmless agreement shall be binding upon the parties hereto, their agents, successors and/or assigns.

The undersigned hereby declares that this hold harmless agreement has been completely read and is fully understood and voluntarily accepted for the express purpose of precluding forever any claims against Krewe arising out of the aforesaid activities.
